Explanation of Responses:

Pursuant to the ESPP, the price used for each quarterly purchase is the lower of 90% of the fair market of the Issuers shares on the first day of the calendar quarter or the closing price of the shares on the last day of the quarter.
- Represents shares acquired by the reporting person in the ESPP pursuant to the reinvestment of dividends received during the quarter on shares held in the ESPP by the reporting person at the time such dividend was paid. Pursuant to the ESPP, the price used for each dividend reinvestment is the closing price of the Issuers shares on the last day of the quarter.
- The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$32.00 - \$32.155 inclusive. 9. These options vest in four equal annual installments beginning one year after the 12/16/2011 date of grant.
10. Such options will vest on 12/31/2017 if specific performance metrics are satisfied, as determined by the Board of Directors.
11. These options vest in four equal annual installments beginning one year after the 11/16/2016 date of grant.
